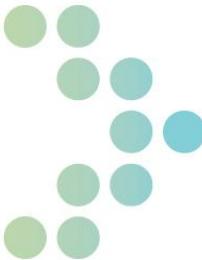

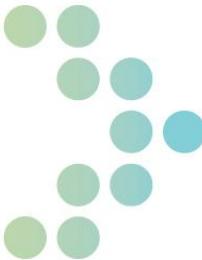

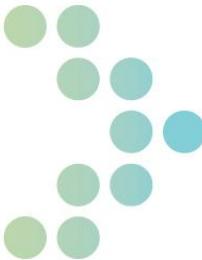

Glen pharmacy

In a nutshell...

- Improvement in efficiency and safety using:
 - Robotics and automation
 - Bar code technology
- Improved medication access point-of-care automation INTERFACED with pharmacy e-profiles
- State of the art sterile IV rooms
- State of the art Oncology IV rooms
- State of the art compounding facilities for individualized oral syringes (ped)
- Specialized clinical pharmacist presence on patient care units and clinics
- Research pharmacy services within central pharmacy


GLEN Pharmacy


- 1 main pharmacy (Ground floor)
- 4 Satellite Pharmacies:
 - ICU adults
 - Oncology Adults
 - NICU/PICU
 - Oncology peds
- GLEN services
 - Clinical pharmacists: medical, transplant, hem/onc, CCU,Peds
 - Medication dispensing all inpatient units
 - Medication stock replenishment: clinics,OR
 - MUHC Chemotherapy: Preps for Glen Cancer Center and MUHC sites (MGH, MNH)
 - Parenteral Nutrition for all MUHC

GLEN Pharmacy

- Opening hours (Main) 8:00 à 22:00
- Pharmacist and technician on call (1 adult + 1 Peds)
- 1 Robot -Rx
- 2 Pacmed (Pill packager)
- 2 Med-carousels (inventory)
- 84 automated cabinets (1 per 12 beds + 1 per OR theater)
- 4 pneumatic tube systems connected to all floors and satellites. (1 per 12 beds+ clinics et satellites)
- 5 Sterile rooms for IV preparations
 - 3 regular/research,
 - 2 oncology)
- Prescriptions: FAXED/SCANNED FOR NOW UNTIL e-Prescribing (2015-16)

- *: Nombre d'ordonnances estimées basée sur une augmentation de 10 % du volume d'ordonnance par an, mais ajusté pour une diminution de lits de 950 à 832 (87% des lits actuels)
- Situation préoccupante au niveau des effectifs:
- 6,6 postes pharmaciens non-comblés
- 12 congés de maternités pharmaciennes en cours ou prévus, 13 maternités techniciens,
- 65% des effectifs sont des femmes de moins de 45 ans...

What was done in preparation for the move in the past 3 yrs?

- Extensive process reviews:
 - Sterile IV rooms: Order of pharmacists visit, complete process reviews
 - Oral medication (24h cart , Uni-dose packaging)
 - Nurses Electronic Medication administration sheets
 - Automated cabinets on certain units
 - Harmonization of clinical practice

Projet “circuit du médicament”

- Divergent and outdated clinical practices and tools were present across the MUHC
- Timing was right – redevelopment project
- Opportunity – Government priority and funding technology
- Complex, multifaceted project involving all MUCH sites requiring bundling of practices and direct involvement of many different professionals and departments
- Complete project management team from the **Transition Support Office (TSO) in place October 2011**
- Implementation across all sites
- Overall project was a MAJOR SUCCESS and allowed us to standardize practices and these will be present at the GLEN and uniform accross ALL MUHC sites

Activation


Major Milestones

- Substantial completion scheduled for September 30, 2014;
 - Activation begins October 1, 2014;
 - Research Institute moves in February, 2015
 - RVH moves in April, 2015
 - MCH moves in May, 2015
 - MCI and MGH move in June, 2015


Substantial Completion

- The facility can be used for its intended purpose notwithstanding minor deficiencies;
 - Activation by the MUHC can begin in anticipation of the moves that will occur in the spring of 2015;
 - List of minor deficiencies is established and correction of same begins;
 - Timing for correction of minor deficiencies is established with the PPP partner, based on MUHC's requirements.






The Activation Period


- Correction of deficiencies and incomplete work by the PPP partner;
 - Final deliveries and clinical testing of equipment, systems, etc.
 - Training and orientation of all MUHC employees that will work at the Glen site;
 - Several MUHC construction related projects that are essential for the opening of the Glen facility;

Activation Planning Teams

- More than 750 MUHC employees are currently working on activation plans in anticipation of the start of the activation period;
- Activation Group includes Clinical personnel, Research Institute employees and various support groups from the MUHC;




Incomplete Work

- Normal for a project of this nature to have minor deficiencies and some incomplete work;
- Completion dates will be established to ensure that the correction of deficiencies and completion of work will not have a material impact on MUHC activation, move or opening;
- MUHC project team and the Project Manager will monitor the PPP partner's progress to ensure compliance with contractual dates for completion of all such work.







The Claim for Compensation

- Discussions continue with a review to resolve on a negotiated basis;
 - Will likely require several more months;
 - Current focus of both parties is on completion of the project;
 - The MUHC is working in collaboration with the Executive Director's office, the MSSS and SQI;
 - Appropriate resources have been deployed to ensure our interests are properly represented and defended and that we achieve the best possible outcome.






The Relationship with GISM

- There remains some contentious issues to be resolved with our PPP partner, including, the administrative framework regarding incomplete work; differences as to whether certain work is “in scope” or “out of scope”.
 - The relationship remains constructive notwithstanding said differences;
 - Over the next 30 years, GISM will maintain and repair the facility and as such, preserving a constructive relationship is important to both parties.

- There remains some challenges to attain substantial completion on September 30, 2014; we remain optimistic that this date will be achieved;
 - The activation period will require a significant and concerted effort by many MUHC employees to ensure a successful transition to the Glen in the spring of 2015;
